Minutes from September 21, 2021 Meeting – Carla Dupree

COVID 19 Update – Candace Sibley

222 cases in January. 439 cases all year. 3 in February. No big upswing from Winter Break. Now accepting rapid antigen tests to get students back in school as fast as possible because the wait was 3 - 5 days, and some were testing negative.

Health Office Updates-Candace Sibley

Have seen some flu cases. All hearing and vision screenings are complete. Considering outsourcing next year to complete within the first few weeks of school. The asthma action plan has been updated. Nurse Sibley is not certified to train in Stop the Bleed. March 11th, Aurora is coming to do vaccinations for students.

CASA Presentation – Breanne Bradshaw - had to postpone. She will be joining us on April 26th.

Food Services Update – Jeffrey Bailey, Chartwells / Kim Blankenship, Director of Child Nutrition

Shared documentation of how many students are eating breakfast and lunch in the cafeteria. Encourage parents to take advantage of the program. Mrs. Dupree introduced Mrs. Blankenship. She gave work background. She reported on grant to purchase more fresh fruits and vegetables.

Upcoming Requirements/Initiatives of the SHAC Committee – Carla Dupree

HB 1525 Update - There must be notice given of meetings posted at least 72 hours in advance and there must be a recording or video of the meeting. This recording or video along with the minutes of the meeting must be posted on our website.

If human sexuality instruction is provided to students, the local school board shall call on the SHAC to provide recommendations on curriculum.

Pleasant Grove does not provide human sexuality instruction other than what is outlined in the TEKS by the state for certain courses such as health and biology. These TEKS can be viewed by anyone at anytime at <https://tea.texas.gov/academics/curriculum-standards/teks/texas-essential-knowledge-and-skills>

Senate Bill IX - SHAC shall provide recommendations on curriculum related to preventing child abuse, family violence, sex trafficking and dating violence. We are waiting on further guidance and clarification from TEA as to the intent of this bill. What are they wanting and for what age groups. At this time, there is not enough information for us, as a committee, to make decisions. I will notify you when TEA provides further guidance.
