

INTERLOCAL AGREEMENT for a JOINT ELECTION

This Interlocal Agreement for a joint election, effective upon approval by the Bowie County Governing Body and the Pleasant Grove ISD, is entered into by and between Bowie County, Texas, and the Pleasant Grove ISD.

Whereas, Texas Election Code Chapter 41, Section 41.001 states that each general or special election must be held on a uniform election date which, for the County and the School, is November 8, 2022.

Whereas Bowie County, Texas, and the Pleasant Grove ISD, Texas, find and determine that the County's general election and the school's special and general election should be held jointly in the election precincts that can be served by common polling places.

Bowie County and Pleasant Grove ISD agree as follows:

1. For the November 8, 2022, Uniform Election Date, the General Election of the Pleasant Grove ISD shall be held jointly with Bowie County's General Election on November 8, 2022, at all Voting Centers opened by Bowie County. PGISD voters can vote on PGISD Trustee Candidates at any Vote Center established by Bowie County for the November General Election.
2. Bowie County, Texas, and Pleasant Grove ISD will conduct joint early voting by personal appearance at the times and locations as established by Bowie County for the November general election.

3. Bowie County will conduct voting by mail for the joint election and applications for voting by mail must be submitted to:


4. Bowie County will provide secure election equipment for all precincts for the joint election.
5. Bowie County, Texas, and Pleasant Grove ISD will share electronic voting machines at common polling places. Bowie County will bear the cost of these machines.
6. Bowie County will appoint and compensate the respective election officials (Polling Judges and Alternates, Early Voting Clerks, etc.) for time and services provided as allowed by law.
7. Bowie County, Texas, and Pleasant Grove ISD will post the election results for the Pleasant Grove ISD elections.
8. Bowie County, Texas, and Pleasant Grove ISD will each be responsible for the cost of any published legal notices required by law.
9. Bowie County will provide the necessary information and confer with the Pleasant Grove ISD to conduct the canvass of the returns of the Pleasant Grove ISD elections.
10. Any further expenditures to be incurred pertaining to the joint elections not specifically addressed above will each be paid by the respective party incurring the expenditure.
11. For the November 8, 2022, joint election, and except as provided below, Pleasant Grove ISD agrees to pay Bowie County, Texas, the sum of **\$ 4,100**.
12. IT IS UNDERSTOOD that the Pleasant Grove ISD shall indemnify and defend the County of Bowie and save it and them harmless from and against any and all claims, actions, damages, liabilities, and expenses of any kind or nature resulting in loss of life; personal, or bodily injury; and/or damage to property arising from or out of any occurrence resulting from the Pleasant Grove ISD's actions under this agreement, regardless of who asserts such claim.

Both parties agree and acknowledge that these sums fairly and accurately estimate Pleasant Grove ISD's share of the joint election costs for the respective general and special elections anticipated; provided, however, that upon the cancellation as allowed by law of any elections, no sum shall be owed for the respective election that is cancelled.


